The Mission and Endowment committee has worked hard this year updating their Policy and Administrative Guidelines. I would like to thank that committee under the guidance of Jodi Spilde and Kathy McHenry for their hard work and time they have spent on these documents.

I would like to ask for a motion to approve the Endowment Policy and Administrative Guidelines for Lutheran Church of Our Redeemer.

 Seven Delegates needed for the 2024 South Dakota Synod Assembly, May 31-June 1, 2024 at Our Savior's Lutheran Church in Sioux Falls, SD

Lutheran Church of Our Redeemer is allowed 7 delegates to the South Dakota Synod Assembly which will be held May 31- June 1 at Our Savior's Lutheran Church in Sioux Falls.

I would like to open the floor up to any persons who would want to represent our church at the South Dakota Synod Assembly.

Jack Holmquest will attend the SD Synod Assembly. Any others can call the church office if they would like to attend.

 Year-end surplus of \$82,700.53; recommend dispersing \$27,736.98 to 2024 Budget, \$40,000.00 to Capital Improvement dedicated line, \$10,000 to Church Home Design & Improvements dedicated line, \$2,463.55 to Ukraine Families Ministry dedicated line, \$1,500 to South Dakota Synod and \$1,000 to Salvation Army One Roof Project.

We ended the church year with a surplus budget of \$82,700.53. At the January Church council meeting, we discussed what to do with the surplus. This is the recommended suggestion of the church council - \$27,736.98 to the 2024 Budget to balance; \$40.000 will be put into the Capital Improvement dedicated line item for further maintenance to our church home; \$10,000 will be put into a dedicated line item for Church Home Design and Improvement which will include paint, new furnishings, decor, etc.; \$1,500 will go to the South Dakota Synod as we had an additional request from the synod, \$1,000 to the Salvation Army One Roof Project, and \$2,463.55 to the Ukraine Families Ministry Dedicated line item.

Motion made to approve the budget surplus disbursement by Kristi Reierson. Seconded by Lynn Langner. Motion carried.

Presentation and Approval of 2024 Proposed Budget

Council members will be handing out 2 pages - They are amended 2024 proposed budget pages 27 and 31. Page 30 of the proposed budget will remain the same. When the church council met in January and approved the proposed budget in the annual report, we did not catch a software calculation error and a new employee has been hired. The church council met this morning and approved the amended 2024 proposed budget. Roman Gainor was hired as the new custodian as a part time position. Therefore, on page 31 line item, Major 8 minor 2 custodial services has been adjusted to reflect the decrease in expense. The preschool salaries on page 31 which is item Major 9, minor 1 was not added to the total expenses. We have added the correct amount for these salaries into the expenses. Since it was decided not to do an official stewardship drive with pledge cards this year, the council took a conservative approach to the income line on page 27. The council decided this morning to add \$57,590.91 to the non promised item to increase the income to match the expenses. As we have asked in the past, the council is hopefully each member will prayerfully consider increasing their giving a bit this year. The proposed budget includes a 5% increase in church employee salaries. The amended 2024 proposed budget is \$1,076,987.24.

As the outgoing congregation council president, I am pleased to have served this congregation for the past year. This was the first full calendar year for our pastors and my sense is that it has been a very successful one. This congregation has much going for it, and the future looks bright!

- Roof Project: After several years of study and diligent effort by many members of this congregation, our roof was finally replaced this past spring. The cost was \$233,899.04. The funds were raised through a very successful capital campaign. Thanks to all who worked so hard to make it successful.
- Debt Reduction: After replacement of the roof, the campaign surplus of \$95,930.05 was applied to the principal on our mortgage debt.

In addition to such major accomplishments, the congregation council works hard with various committees, as well as regularly performing its duties under our church constitution. Those include the oversight and administration of the congregation to enable it to fulfill its functions and perform its mission, maintaining and protecting the church's property and managing its business and fiscal affairs, preparing the annual budget and supervising the expenditure of funds, and generally managing the congregation's affairs. The Mission Fund is comprised of donations, both designated and undesignated, primarily from memorials.

The Endowment Fund was created to extend Lutheran Church of Our Redeemer's misson work and ministries beyond what may be accomplished through the annual operational budget of the congregation by managing monies and property gifted to LCOOR by members and friends.

At the annual meeting of the congregation in January 2024, the congregation voted to approve the new Gift Policy and also the Endowment Policy and Administrative Guidelines for the LCOOR Constitution. It has been a process, but the committee has worked through it and implemented the changes. A new brochure that highlights giving to the Endowment Fund will soon be printed and handed out to the congregation.

The Mission and Endowment Committee of LCOOR provided the following funds in 2024:



Youth Mission Trip: Led a team with Serve Boldly to Duluth, Minn., at the end of June for one week. Activities included morning devotionals, community service projects throughout the city of Duluth and evenings we ended each night with a church service.

The Property Committee thanks the many members who have given countless hours toward keeping our church property in order. Numerous tasks are taken on by these volunteers, including mowing, landscaping, etc.

This year was another busy year for the property committee, as the church is 21years old. Many items needed to be repaired or replaced, and more will be in the future. In 2023, a priority list of these items was made, and given to the council, on future needs over the next 10 years.

#### Completed items include:

- The largest project was replacing the entire church roof. After many meetings and discussions, we decided on Skywalker roofing from Brookings. The bid was for \$230,574.04 but additional cost was added as numerous wood sheets needed to be replaced due to rotting.
- Replacing sections of sidewalk concrete, due to cracking and unevenness for \$3862.00.
- Rekeying all the exterior door locks in the church, as there were many unreturned keys. (Now keys can be checked out in church office if needed.)
- Hiring Justin's Lawn & Tree Service for mowing and trimming. This was their 2nd year.
- · Replacing burned out lights in the parking lot.
- Placing aluminum plates at both exterior entrances and kitchen entrance, to alleviate the concrete unevenness. Thanks, Tim and Dale for doing this.
- Hiring Deutsch Excavating for snow removal from the church parking lot. (He has done it for numerous years with excellent results.)
- There is one more big project in the works at the time of this report: the air conditioner in the gathering area. The
  committee is deciding whether to replace or repair. The cost to replace is approximately \$79,000. This committee
  recommended to the council to replace.
- · Shampooing of the fabric of all of the church pews.

The property committee will continue to keep the Council informed, as well as the congregation, of what is ahead. We continue to be committed to keeping the church a welcoming site.

Our Synod's vision of Journeying Together in Christ has continued to be the focus of our work. We invite you to take a few moments to review the list below which celebrates some of the ministry we shared together in 2024. **Journeying together in Christ as the South Dakota Synod, in 2024 we have:** 

- Applied and received a grant of \$1,224,172 from Lilly Endowment, Inc. for the Synod's Holy Playground Initiative, which will
  provide strategic support for children's ministries in congregations and worshipping communities.
- Completed explorations for a potential church plant, with plans to start a worshiping community in Box Elder.
- Received 2 new first call candidates.
- Completed 22 Ministry Site Studies and extended 19 calls.
- Ensured that nearly every congregation has a called pastor, interim pastor, Synod Authorized Minister, or lay leader to care for God's people (thank you to all of you who are helping out with area congregations and filling in!).
- Walked with 25 people in various stages of candidacy in the SD Synod in 2024, with 18 others inquiring and in discernment.
- Granted **\$119,990** in scholarship funds to seminary students, **\$28,500** in internship assistance, and **\$38,232** to Luther and Wartburg Seminaries, for a total of **\$186,722** in support for seminary education.
- Distributed \$48,220 to date through the Seminary Debt Reduction Program.
- Helped members and congregations recover from severe weather events, including awarding \$20,000 in Storm Micro Grants
  and working with congregations to secure grants from Lutheran Disaster Response.
- Held a **Synod Assembly**, where we gathered as a community to conduct the business of the Synod.
- Hosted Spring and Fall Theological Conferences, where we continued to support the continuing education of our Rostered Ministers either online or in-person.
- Supported the congregations and ministries of the Synod through visits by Synod staff, both digital and in-person.
- Hosted "Coffee with the Bishop" for Retired Rostered Ministers, Spouses, Widows/Widowers.
- Received nearly 300 enrollments from over 100 SD churches to Pasque Learning Community, our community effort to
  promote Spirit-led growth and faith formation. At Pasque, you can find 10 online courses with relevant instructional videos
  and digital discussion, as well as live weekly Zoom sessions, 4 active communities, and 2 digital downloads.
- Hosted "I've Been Elected to Council, Now What?" to support congregational lay leaders and supported rostered lay leaders with regular in-person and virtual meetings, such as monthly rostered minister virtual check-ins, Synod Authorized Minister, Senior Pastor, and Interim Pastor check-ins, and a First Call and Senior Pastor Retreat.
- Welcomed Rev. Joel Pakan as the new **Director for Rural Ministry**, where he has journeyed with our rural ministry sites.
   Rev. Pakan has continued to work with 14 communities and congregations in transition.
- Continued the work of the Rural Ministry Table, which is currently working on Small Town and Rural (STAR) grants, we awarded \$84,139.
- Partnered with Grand Valley Lutheran to hold a Farm to Table Dinner, which resulted in gifts of \$44,710 to support rural
  ministry in South Dakota.
- Recieved \$103,700 in Churchwide grants for our Neighbors in Solidarity ministries.

Thank you for all the ways you have supported the ministry of the South Dakota Synod. Together we continue to serve as the hands and feet of Christ, sharing Jesus' love and grace. As we step into 2025, we trust in God's guidance and look forward to walking this journey of faith together.




