Review / Approve November 2024 Treasurer's Report: Budget for the month of November was \$89,748.00. November income was \$80,260.86 which is \$9,500 below budgeted income. Of note, general offering was up \$4,337 from last month and loose offering was up \$2,284 also. November expenses were \$90,006.88 which were on target for the month. Total revenue year to date is \$934,950.25 and total expenses year to date is \$953,725.31. Yearn to date we are \$18,802.06 over budget. Noisy can for November raised \$836.80 to be split between Fallout Shelter and Salvation Army One Roof. Each will also receive \$500 as budgeted. Motion by Ann D, second by Jessica K. Motion passed.

Pastor Laura made cookies made with confirmation class. More supplies are being purchased through Thrivent Grants for additional kitchen utensils and supplies. Both pastors will be working with Wendy to help fill the gap in Phil's absence. Will be working with the committee and council to assess future youth and family needs and develop the Faith Formation job description. Family bingo will be held and Pastor Dan will be the caller for this. Planning a mission trip for high school students to Madison WI June 22-27 and also Sioux Falls Feb 7-9th for middle school students. RSVP is due by 1/7/2025. Pastors will be on a pastors only mission trip to Egypt that will be Jan 15-23. Communion to individuals in the home will be completed prior to Christmas. 3 visits were completed at nursing homes. LCOOR is participating in "Young At Heart" and "Elemental Ministry" programs through St Olaf. The goal is to embrace children as full participants in the body of Christ. This begins Jan 2025.
