Review / Approve October 2024 Treasurer's Report: Income for October was \$73,840.86 and expenses were \$95,599.33, creating a deficit of \$19,758.47. Budgeted income was \$89,748.94 and expenses at \$89,748.91. Budgeted surplus has now been eliminated. Expenses for the month were over budget by \$3,850.39. Income for the month was under budget by \$15,908.05. Mission of the month was Cameroon Partner Ministry which an additional \$967.54 from the Noisy Can raised. LCOOR has received \$2,647.00 in Thrivent Choice Dollars which are in dedicated accounts and the Preschool has received \$1,362.00 which supplement the income of the preschool.
